CITY RESOLUTION NO. 2019-083

A RESOLUTION AUTHORIZING THE POLYTECHNIC COLLEGE OF THE CITY OF MEYCAUAYAN (PCCM) TO OFFER A NEW DEGREE PROGRAM/COURSE (BACHELOR OF SCIENCE IN OFFICE ADMINISTRATION/OFFICE MANAGEMENT - BSOA) FOR ACADEMIC YEAR 2021-2022, AS PER PCCM BOARD RESOLUTION NO. 2019-06.

WHEREAS, Section 17 (a) (b) (4) (ii) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" mandates that:

"SECTION 17. Basic Services and Facilities. -

- (a) Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein.

WHEREAS, the City Government has been exceptionally supportive towards the advancement and strengthening of the operation of the College on its implementation of additional academic programs since its existence;

NOW, THEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, that this Sangguniang Panlungsod hereby **AUTHORIZE** the POLYTECHNIC COLLEGE OF THE CITY OF MEYCAUAYAN (PCCM) to Offer a New Degree Program/Course (Bachelor of Science in Office Administration/Office Management - BSOA) for Academic Year 2021-2022, as per *PCCM BOARD RESOLUTION NO. 2019-06*.


