CITY RESOLUTION NO. 2019-096

A RESOLUTION RESPECTFULLY REQUESTING HIS HONOR, RODRIGO ROA DUTERTE, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, TO DECLARE THE TENTH (10th) OF DECEMBER OF 2019 AS A "SPECIAL NON-WORKING HOLIDAY" IN THE CITY OF MEYCAUAYAN, BULACAN, TO BE KNOWN AS "ARAW NG LUNGSOD NG MEYCAUAYAN".

WHEREAS, Section 458 (a) (5) (xvi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" mandates that:

"SECTION 458. Powers, Duties, Functions and Compensation. -

(a) The sangguniang panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, and shall:

(5) Approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities as provided for under Section 17 of this Code, and in addition to said services and facilities, shall:

(xvi) Establish a City council whose purpose is the promotion of culture and the arts, coordinate with government agencies and non-governmental organizations and, subject to the availability of funds, appropriate funds for the support and development of the same.”;

WHEREAS, the City of Meycauayan was founded on December 10, 2006, as the vast majority of its people Ratified Republic Act No. 9356, otherwise known as “AN ACT CONVERTING THE MUNICIPALITY OF MEYCAUAYAN IN THE PROVINCE OF BULACAN INTO A COMPONENT CITY TO BE KNOWN AS THE CITY OF MEYCAUAYAN” in a plebiscite conducted for that purposes;


WHEREAS, the City deems it appropriate to set aside a day in every year to commemorate its founding anniversary to instill in its citizenry a sense of righteous pride and nationalism;

NOW, THEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, to **RESPECTFULLY REQUEST** His Honor, RODRIGO ROA DUTERTE, President of the Republic of the Philippines, to *Declare the Tenth (10th) of December of 2019 as a “Special Non-Working Holiday” in the City of Meycauayan, Bulacan, to be known as “Araw ng Lungsod ng Meycauayan”.*


RESOLVED FINALLY, let copies of this Resolution be sent to all concerned offices for their information and concluding action.





